Recovery Now Fund

- Created by the RELIEF Act of 2021 to support Maryland businesses and individuals in need of assistance as the result of the pandemic.
- Supported by a \$306 million transfer from the State's Rainy Day Fund.
- The fund supports 34 programs administered by 16 State agencies.
