After nearly two-thirds of Maryland voters approved a referendum to legalize adult-use cannabis, the General Assembly passed sweeping legislation to govern oversight, licensure, taxation, and social equity issues. However, many questions remain about the burgeoning industry. Ambiguous restrictions on local zoning, incommensurate revenue sharing, human resources considerations, public health, and public safety are all top of mind for county governments.
